# **Defending Diversity**

This year's AGM theme is Defending Diversity and as we prepare for this year's conference we are seeing significant and troubling attempts by far right commentators and political parties to cultivate the sort of negative attitudes to diversity and inclusivity which in the 1930s, resulted in the rise of Nazism and the mass carnage that followed.

It's often said that ignoring the lessons of the past increases the likelihood of the same mistakes occurring again; and that's why Napo, alongside our sister trade unions, has an important role to play in speaking out against intolerance, injustice and exploitation.

Throughout all of Napo's proud history, our members have campaigned vigorously in support of the basic tenets of a civilised society which include the need for equality and respect for all. Sadly, in the wake of the decision to leave the European Union, we are now witnessing a significant rise in hate crime, unprecedented attacks on the basic rights of trade unions to organise and defend their members against multinationalism, cuts to welfare support for the poorest sections of our communities, the scapegoating of desperate refugees, sexism at the workplace and attempts by some unscrupulous employers to turn the clock back in terms of employment practices.

The 2017 AGM will be a celebration of the rich heritage of cultural diversity across our membership, but it will also send an important signal that this union is proud of its contribution to the progressive reforms that have been achieved by trade unions, and that we intend to do all we can to oppose those with a different agenda.

I look forward to seeing you in Nottingham and working with you all in the campaigns ahead.

## **New look AGM**

This year's AGM is the first of Napo's two-day annual conferences. It is located in the EMCC, a purpose built conference centre in the grounds of the University of Nottingham a short (10-15 minute) journey by tram from central Nottingham. The change to two days and the location has meant structuring conference differently this year so attendees are asked to pay close attention to the timings in the provisional programme (below).

AGM will start at 9.30am on Friday 13th October and finish at 4.00pm on Saturday 14th October

On Friday afternoon conference will split into a Family Court and a Probation Professional Session from 2.30pm until 4.00pm. There will then be an extended debate session, interspersed with keynote speakers, finishing at 7.00pm. This will be followed by a drinks reception for all attendees.

Because of the location and the timings we will be providing a hot buffet lunch for all attendees on both days. This will be included in this year's registration fee.

There will be optional lunchtime professional focused fringe meetings on the Friday lunchtime and entertainment on the Saturday lunchtime. The lunchbreak will be extended to allow attendees to have lunch and participate in lunchtime activities.

We will have a large number and range of exhibitors and stalls from campaigning groups, member service providers and other research and information organisations, as well as Napo's national committees.

# **Debate and discussion**

As usual AGM will discuss and vote on a wide range of motions from members and branches. Motions to be considered by the AGM may be submitted by the NEC, a national committee, a Probation Branch, the Family Court Section, the PSO Forum or any two full or professional associate members of Napo. Constitutional amendments may be submitted only by the NEC this year.

Motions should be submitted on the form provided which is available from Annoesjka Valent (avalent@napo.org.uk – 020 7223 4887) at the Napo office. Motions must reach the General Secretary no later than 12 noon on **Friday 18 August**. Amendments to motions and amendments to constitutional amendments must reach the General Secretary by 12 noon on **Friday 29 September**. Details of motions and constitutional amendments received will be circulated to members at the end of August.

- 4 Conference credentials, voting papers (as appropriate) and information will be sent out to the address on the registration form after 2 October.
- 5 If you wish to bring a guest to conference, such as a partner, please indicate on the form overleaf. This year retired or unwaged guests can attend for the concessionary rate of £37.75, including lunch. Other guests will be required to pay the full rate of £57.75 (including lunch).
