

# Labour

#### Probation & Prison

- End public sector pay cap to increase recruitment and retention in prisons and probation.
- Publish prisoner/staff ratio reports on an annual basis to maintain safety and end overcrowding.
- Recruit 3000 prison officers and review training.
- Personal rehabilitation plans for all prisoners.
- Embed the belief that prison should be the last resort.
- Review mental health provision in prisons.
- No new private prisons.
- Embed restorative justice in Youth Offender Institutions.
- Review the role of Community Rehabilitation Companies and part privatisation has failed.

#### <u>Justice</u>

- Appoint a commissioner to set new standards for tackling domestic violence and sexual violence.
- Create a national refuge fund.
- Strengthen the law banning community resolutions for domestic violence.
- Review the PREVENT programme its effectiveness and potential to alienate communities.
- Keep the Human Rights Act
- Launch an inquiry into Orgreave and black listing.
- Re-establish early advice entitlements in Family Court.
- Remove the requirement for domestic violence victims to pay for a doctor's certificate.
- Legislate to prohibit cross examination of domestic violence victims by perpetrators.
- Re-introduce the funding for the preparation of Judicial Reviews.
- Review legal aid means testing including capital test for those on income related benefits.
- Consider reinstatement of other legal aid following the recommendations from Lord Bach's report.
- Introduce no fault divorce procedures.

#### **Equality**

- Gender audit all policy and legislation to assess the impact on women.
- Work with the Assembly to extend rights to abortion to Northern Ireland.
- Reverse employment tribunal fees.
- Extend the time period for applying for maternity discrimination to 6 months.
- Work with the Health and Safety Executive to introduce mandatory workplace risk assessments for pregnant women.
- Review support for women who miscarry.

## Conservative

#### Probation & Prison

- Prisons should be places of safety, discipline and hard work. 'We will help prisoners to learn English and math and work skills'.
- Invest £1 billion to modernise prison estates. Replacing old prisons and creating 10,000 new prison places in modern prisons.
- 'Community punishments don't do enough to prevent crime or break the cycle of crime. We will create a community sentencing framework with a view to punishing offenders and focus on measure that turn lives around e.g. curfews, drug/alcohol orders'.
- Dedicated provision for women offenders.
- Reduce disproportionate use of violence and force against BAME people in prison, YOIs and mental health institutes.

#### <u>Justice</u>

- Widen the role of Police and Crime Commissioners to sit on health and well being boards to assist with drug and alcohol crime prevention.
- Greater devolution of the Criminal Justice System.
- Explore ways to improve family court justice. Family Courts need to be doing more to support families.
- Introduce a Domestic Violence and Abuse Bill Legislate to define domestic violence in law and review funding for domestic violence refuges.
- Remain signed up to the European Court of Human Rights for the duration of this parliament.

#### Equality

- Take measures to close the gender pay gap.
- Improve take up of shared parental leave and encourage flexible work environments to help mothers and fathers share parenting.
- Support companies to take on parents and carers returning to work.

#### <u>Other</u>

• Introduce the requirement to show photo ID to vote.

## Liberal Democrats

### Probation & Prison

- Introduce a presumption against short term prison sentences.
- Increase tough none custodial sentences weekend and evening custody, curfews, community service and GPS tagging.
- Transform prisons into places of rehabilitation education, work, treatment and ensure courses that are started in prison continue in the community.
- Ensure transgender people are in the prison that reflects their gender identity not their birth gender.

#### <u>Justice</u>

- Reduce over representation of BAME people in the justice system.
- Secure further funding for legal aid (not from the tax payer) through company insurance, company directors and changes to restraint orders.
- Promote community justice panels and restorative justice.
- Extend Youth Justice Boards to 21 year olds.
- Establish Women's Justice Boards.
- Review investigation, prosecution, procedures and rules of evidence in sexual offences and domestic violence.
- Retain international jurisdiction for family cases.
- Comprehensive review of legal aid access to justice for welfare appeals and domestic violence cases.
- Reverse court and tribunal fees.
- Modernise and simplify the court procedure.
- Protect the system of Judicial Review.

### **Plaid Cymru**

- Reverse cuts to legal aid.
- New laws to protect victims of domestic violence and rape to enable them to give evidence without intimidation.
- Block the super prison being proposed in Port Talbot and create much needed space for women and young offenders.
- Create a Welsh jurisdiction and justice system to reflect welsh needs.
- Create a Human Rights Charter for Wales

### **Green Party**

- Implement UK wide strategy to tackle gender based violence domestic violence, rape, sexual abuse, FGM and trafficking.
- Revive role of democratic trade unions.
- Defend the Human Rights Act.
