RICHARD BURGON MP TAKES THE ROSTRUM:

Joining AGM attendees at 6pm on Friday evening, the Leeds East MP gave members a boost

Committed socialist and trade unionist, shadow justice secretary Richard Burgon was a hit with Napo members on the first day of conference.

His assertion that "privatisation does not work - at least for society" was in line with much of what we have previously heard from his Party, but he went a step further stating that Labour will be conducting a review into the CRCs.

"Through our review, we will be looking at how and when it would be possible to bring probation back under public control," the MP for Leeds East told conference.

"I personally believe it is immoral to be running our justice system for profit," said the shadow justice secretary, who also described Transforming Rehabilitation as "economic vandalism".

SENIOR LECTURER LEEDS BECKETT UNIVERSITY

Dr Erica Laredo has spent the past two years juggling her job as a lecturer with her research into sex workers in a "managed area" in Leeds.

The innovative scheme allows sex workers to operate without fear of arrest in a prescribed area and certain time.

Dr Laredo spoke to Napo members about the projects she is involved in, one of which offers day-to-day support for women who work on the street at night.

"I didn't consider myself a naive person, but i hadn't realised the level of abuse women sex workers receive," she said.

Secretary of the Venezuela Solidarity Campaign, Dr Franciso Dominguez was ideally placed to speak to conference about Venezuela's fight for social justice being a Chilean socialist who fled the country after the coup of General Pinochet.

Now head of Latin American studies at Middlesex University and co-author of the "right Wing Politics in the New Latin America", Dr Dominguez is a passionate speaker against Trump's aggressive agenda.

"The attack against Venezuela began in 1999. Venezuela has the curse of having the largest oil deposits of oil known in the world... Think about it," he told members.

"This is the move to pleading guilty online, being sentenced online... You didn't know about this?" he asked the shocked audience.

The proposals are apprently detailed in the new Courts Bill, which Napo is sure its members will be keeping a very close eye on.

Working with Dr Christine Hough at the University of Central Lancashire, Arooj a third sector voluntary organisation based in North West Lancashire gave a presentation to a packed room of Napo members at Friday lunchtime. Arooj explained their unique three stage approach to mentoring BAME and Muslim offenders and the need to focus on working closely with the family as well as the client. The support from Arooj starts when the client is on the inside enabling them to build a trusting relationship (Stage 1) and then continues on the outside, when they signposting to relevant agencies (Stage 2) and finally they offer support for life to the client and the family (Stage 3). The fringe meeting went on to explore the negative impact of TR on the work delivered by

Arooj and the consequences for securing successful rehabilitation outcomes and reintegration into the community. Napo members had the opportunity to ask questions to Hanif and Tariq from Arooj and to share best practice on ways to work with BAME and Muslim clients.





Napo members at AGM 2017 heard Hugh Robertson, health and safety senior policy officer at the TUC speak at a fringe meeting about the increasing use of "wellbeing" packages by employers.

The concept of wellbeing is everywhere and noted on cat food, paint and tea bags to name but a few. Ongoing studies show that people are healthier if they have more money. Packages have been introduced to try to keep staff in work and to reduce the likelihood of sickness absence.

US companies are spending \$6billion per year on wellbeing initiatives and some penalise employees who do not take part in wellbeing activities.

Many impose contracts where employees agree to live a substance free lifestyle. Employers offer many positive initiatives including stress awareness training, resilience training, the provision of Cognitive Behavioural Therapy and Mindfulness although they do not suit everyone.

The TUC note that many large employers attempt to pass responsibility for work related stress from committee to committee and avoid focusing on prevention.

Take your concerns through Napo officers to your employers Health & Safety Committee. Let the Napo Health & Safety committee know what your workplace issues are in relation to prevention.
